The qualifier is opened to all the players not exempt under the 2014 Challenge Tour Exemption Category Lists.

1. Qualifier

The competition will be played according to the Rules of Golf of the R&A Rules Limited, the 2014 Local Rules and Conditions of the Competition of the Challenge Tour and the Local Rules of Golf Blue Green Val Queven.

- A. The tournament is open to a maximum of 100 players and entries will be accepted in the order of arrival.
- B. The tournament will be played over 18 holes - stroke play formula. All the players will be playing one round on the course referred to in 1/C.
- C. The tournament will take place on Monday 1st September 2014 on the course Golf Blue Green Val Queven (Kerruisseau – 56530 Quéven).
- D. The top 3 players, after playing 18 holes, will qualify to enter the Open Blue Green Côtes d'Armor Bretagne 2014.
- E. Any ties for qualifying spots and/or for the 3 reserves spots will be decided over a hole by hole play-off, immediately after conclusion of play. The hole by hole play-off will be played over holes 10, 9, 10, 9 and so on until the 3 qualifying spot and the first 2 reserves are decided.
- F. If it was not possible to complete 18 holes on the day, the qualifier may continue the day after in case of exceptional circumstances.
- G. If one of the qualified players withdraws, he may be replaced by the first reserve on the qualification ranking up until Tuesday, September 2nd, 12.00 hours. After this date, the place will return to the first reserve on the list of the Categories of French Tour Exemption Category List.

2- Entries

- A. Eligibility :
Every professional from a recognized PGA.
Every male amateur with a maximum handicap of 2 or an index of 2,4 on the system of handicapping of the Federation.
- B. Entry fee:
The entry fee is 50€ for the amateur players and for the professional players and 20€ for the teaching professionals from Blue Green group.
The payment will have to be made:
 - For players living in France: Check payable to the Blue Green S.A
 - Players living outside France: Bank Transfer (see account number below)

- E. Entries for the qualifier will be open from July 30th and will close on August 27th (as attested on the postmark date).
- F. Responsibility of the player: the player must make sure that his registration has reached the Golf Blue Green Val Queven before the closing date of entries.
- G. An acknowledgement of receipt will be sent by e-mail to every player upon receipt of the complete entry form. The players will be considered as entered when they will have received this confirmation by e-mail.

- H. If a player withdraws before the closing date, his entry fee will be entirely refunded upon a written request sent to Golf Blue Green Val Queven. A player who withdraws after the closing date will not have his entry fee refunded under any circumstances.
NB : Any player qualifying for the Open Blue Green Côtes d'Armor Bretagne under the 2014 Exemption Category Lists of Challenge Tour before tee off will be refunded. No qualified player will be refunded.
- I. All the entries will be subject to the Committee's approval which reserves the right to accept them or to refuse them or, having accepted them, to refuse them without giving the reasons of its decision.
- J. The Committee can ask any player to demonstrate, in an independent way, his level of performance. For the amateurs, the licence number will have to be written on the entry form. For the professionals, a PGA card can be requested.
- K. The Committee can disqualify any player providing false information on his entry form.

3- Registration

All the players have to register before 12:00 the day before the qualification (on Sunday 31st August), It can be personally made to the tournament office at the Golf Blue Green Val Queven by signing the tee times sheet, emailing to jg.cirier@ffgolf.org or by phoning to +336 60 83 70 30. The player is responsible for ensuring that his registration by email has been received.

4- Tee Times

Tee times will be available to the tournament office at the Golf Blue Green Val Queven or on <http://frt.ocs-europe1.com/tic/tmtic.cgi> on Sunday 31st August from 15:00.

5- Practice round

All Professionals will be allowed to play a practice round, free of charge, on Sunday 31st August but will have to book a tee time in advance by calling the Golf Club on +33 2 97 05 17 96.
Practice round starting will be closed on Sunday at 17:00.
